POSITION TITLE: Elder Center Cook
DEPARTMENT: Clinic/Elder Center
SUPERVISOR: Clinic Director

**WAGE:** Level 9-0 \$12.04 to Level 11-0 \$13.27 F/T 40hrs/wk

**POSITION SUMMARY:** The primary function of the position is to plan, prepare and serve fresh and healthy daily meals for congregate and homebound Elders.

#### **DUTIES:**

- Prepares a monthly menu and posts it in advance
- Ensures daily meal menu food items are purchased and available for preparation of meals.
- Uses nutritional and portion size best practices to meet the dietary requirements of the clients served.
- Ensures adequate supplies of fresh and nutritionist food items are available to meet the monthly menu scheduling.
- Ensures compliance with Federal environmental health standard practices including food safety, equipment, and facility guidelines.
- Maintains physical presentation of the Elder Center.
- Ensures a clean and sanitary center is maintained for congregate meal serving and other specialty events at the center.
- Reconciles and reports financial receipts for food and center supplies and accounts for participant donations.
- Posts Elder Center activities and sign-up sheets for attendance or participation in upcoming events.
- Attends monthly Elder Committee meetings.
- Supervises assistant cook/driver.
- Perform other duties as assigned.

### **QUALIFICATIONS:**

- Must have a high school diploma or GED required.
- Knowledge of Federal food preparation and kitchen sanitation standards.
- Required to obtain within (6) months applicable Federal food safety and sanitation certifications.

- Minimum of 1-3 years employment in a food industry related position like restaurants, preparing food dishes breakfast, lunch, dinner, buffets, or as a line prep cook preferred.
- Knowledge of meal planning for large groups, special events and parties.
- Must be a team player with an understanding of working with and serving Tribal Elders, working with fellow employees and the Tribal community and dependable.
- Required to obtain First Aid, CPR certification, successfully pass a criminal background investigation and drug screen.
- Able to maintain strict confidentiality.
- Must be able to stand for long periods of time.
- Able to lift 40 lbs or more.
- Possess a valid Nevada Driver's License and be insurable.
- Pass pre-employment drug screen and complete background investigation.
